

Wall & Freestanding Sign Ordinance Summary

- ### License & Bond
- All signs erected inside the city must be erected by a person holding a City of Nacogdoches Sign Contractor's license.
 - Sign Contractor's license fee is \$50.
 - All Sign Contractors must provide the City of Nacogdoches with a \$2000 bond.
 - Sign Contractors who install signs without first obtaining permits may have their license revoked.

- ### Fees
- \$25 Base fee
+\$0.25 / sq. ft. of sign area
+\$10 / ft. of sign height

- ### Wall Sign Allowable Area
- Wall signs may have a maximum size of 1.5 square feet for each 1 linear feet of building frontage.
 - Signs on gas station canopies may include the logo and business name on no more than 3 sides. The total area of the signs shall not exceed 30 sq. ft.

Signs Not Requiring Permits

- Legal notices and address numbers.
- On-premises signs not visible from a public street or under 4 sq. ft. which direct the flow of traffic.
- Construction signs less than 32 sq. ft. Must be removed within 30 days after issuance of a CO.
- Holiday decorations.
- Political signs.
- Real estate signs.
- Window signs.
- Official flags of the government or corporations. When flags become tattered or faded, they must be removed or replaced.
- Special event signs. The City must be notified prior to placement. Signs may be placed 14 days prior to an event and must be removed 2 days after event. The event must be sponsored by a non-profit organization.
- Community support signs.
- Real Estate Signs

Prohibited Signs

The following types of signs are prohibited in all districts:

- Abandoned signs
- Snipe signs or signs attached to trees, utility poles, public benches, or streetlights.
- Signs placed on vehicles or trailers which are parked or located for the primary purpose of displaying the sign. This does not apply to lettering on buses, taxis, or vehicles operating during the normal course of business.
- Portable and trailer signs, except those permitted prior to November 8, 2000. All portable sign permits will expire December 31, 2007.
- Off premises signs.
- Signs painted on rooftops.
- Signs with flashing, traveling, or blinking lights or erratic or moving parts.
- Any sign which emits sound, odor, or visible matter.
- Searchlights.
- Signs on public right-of-way

In General

- The Sign Ordinance applies to all signs within the City of Nacogdoches and its ETJ.
- All signs that are electrically operated or contain electrical components must also obtain an additional permit.
- All signs shall be designed to withstand 90 mph winds.
- All illuminated signs must conform with the outdoor lighting ordinance,
- Signs erected in Historic Districts must first be approved by the Historic Landmark Preservation Committee.
