### Restaurants

- **Allowed** to reopen Friday, May 1st.
- **Limited to 25% capacity.**
- **No tables larger than 6.**
- Parties must remain 6 ft. apart.
- Use disposable menus.
- Do not leave any items on unoccupied tables.
- **No shared condiments** (i.e. ketchup bottles).
- Provide hand sanitizer at entrance.
- Consider having all employees wear cloth face coverings over their nose and mouth.
- Contact-free payment encouraged.
- Employee screening before each shift.
- Sanitation protocols for employees and facility.

### Retailers

- **Allowed** to reopen Friday, May 1st.
- **Limited to 25% capacity.**
- Consider having employees wear cloth face coverings over their nose and mouth.
- Encouraged to dedicate certain shopping times for at-risk customers or provide delivery options.
- Contact-free payment encouraged.
- Employee screening before each shift.
- Sanitation protocols for employees and facility.

### Movie Theaters

- **Allowed** to reopen Friday, May 1st.
- **Limited to 25% capacity.**
- **Keep two seats (6 ft.) empty between parties & leave every other row empty.**
- **Disinfect seats between screenings.**
- Remote ticketing options encouraged.
- No items left on unoccupied tables.
- Use disposable menus.
- **No shared condiments.**
- Consider having all employees wear cloth face coverings.
- Employee screening before each shift.
- Sanitation protocols for employee and facility.

### Museums & Libraries

- **Allowed** to reopen Friday, May 1st.
- **Limited to 25% capacity.**
- **Must keep hands-on, interactive areas closed.**
- Consider having all employees wear cloth face coverings over their nose and mouth.
- Employee screening before each shift.
- Sanitation protocols for employees and facility.

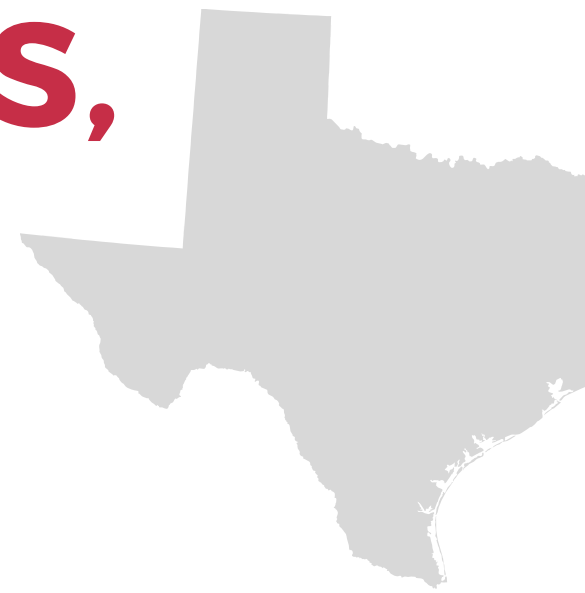
### Outdoor Sports

- Outdoor sports may resume provided that the sport does not include contact with other participants. **These will be limited to groups of four participants.**
- Does **not** include public pools which should remain closed.
- Group size may expand during Phase 2 of additional openings as early as mid-May.

### Church & Other Worship Services

- **Allowed** to expand occupancy Friday, May 1.
- At-risk populations are encouraged to participate remotely.
- Designate an area for at-risk populations or offer a service for at-risk attendees only.
- Keep at least **two seats (6 ft.) between parties** in any row except for two or more members of the same house.
- **Alternate rows between attendees** (every other row left empty).
